1. I agree to pay the annual and monthly fee through the time I remain enrolled as a member.
2. I release the Club, BELLY DANCING BY HABEEBA'S, LTD and its staff from all liability for personal injury incurred by me in connection with or arising out of attending my classes or Club events.
3. I understand that the dance curriculum shared by the Club, BELLY DANCING BY HABEEBA'S, LTD., is special, unique, unusual, exclusive of Habeeba; and can only be taught through Habeeba or her direct representative. I agree that I shall not use lesson plans, curriculum or choreography learned during my membership to teach or perform or to compete with the Club, or Any Habeeba's Dance of the Arts locations.
4. There is an annual \$25.00 registration fee for all members.
5. There are no refunds given for prepaid cancelled membership. Credit for future membership may be given in certain circumstances.
6. No make up lessons can be given to any member who misses class. It is to each member's benefit to attend all weekly classes to keep up with your learning and member classmates. You may attend multiple classes -at or below your level- for practice and review. We support you in learning as quickly as you can.

7. As a rule, our Club does not schedule private lessons. However, Performing "A" Members may arrange for private instruction with Key Performing Members in certain instances.
8. The Club will usually not cancel a scheduled class or event for any reason including weather or holiday, with these exceptions: Memorial Day, Fourth of July, Labor Day, Thanksgiving, Christmas Eve, Christmas Day, New Year's Eve, and New Year's Day. If your class falls on these dates you will be notified as to what arrangements will be made to accommodate your lessons. You may receive a double lesson or be scheduled to join a class on another night.
9. Fees are set by the Executive Committee members and may change over time with 30 days notice.
10. There is a \$35.00 fee for all checks returned NSF.
11. After registering for your chosen class time, you may not transfer to any other class without permission from your Key Member Instructors.
12. Your annual and monthly Club membership payment is required for classes, performing in dance parties, benefits, and activities.
Our Club curriculum is progressive. The longer a Member is with the Club, the more advanced the lesson plan and choreography becomes and the more performance opportunities are presented. There is no requirement for Club members to perform.
13. The Club reserves the right to revoke membership to abusive, disruptive, or unfriendly members.
